- · Platform use service.
- 3. The "Archive Rental" service is provided:
- · for 1 (one) day,
- · for 3 (three) days,
- for 7 (seven) days,
- for a period of 14 (fourteen) days.
- The Archive Storage Rental service is provided according to the price list indicated in Table 1 below.

- c. The Camera(s) remain the property of the Operator.

- d. Installation and dismantling of the camera/cameras can also be performed by the Operator.
- e. "Camera rental" is only available within the operator's coverage area.
- f. Dismantling of the camera/cameras is carried out by the Operator upon request to disconnect the camera (or terminate the current contract). Dismantling of the camera/cameras is carried out at no additional charge.
- g. The Temporary Suspension service is not available as part of the Camera Rental service.
- h. The Camera Rental service is not suspended due to late payments. The monthly fee for the camera/cameras provided as part of the "Camera Rental" service is accrued until the end of the contractual relationship provided for in the Subscription Agreement.

## 6. Transitions

a. It is impossible to switch from the "Monitoring" service to other services of the Operator. It is not possible to switch from other operator services to the Surveillance service.

## 7. Other terms

- a. If the Uniview IPC-3F22P-RB28 and Dahua IPC-HFW1230SP v2 cameras provided to the Subscriber are damaged (the damage is not a consequence of manufacturing defects of the Uniview IPC-3F22P-RB28 and Dahua IPC-HFW1230SP v2 cameras) or lost, then the Subscriber is obliged to reimburse the Operator for the price specified in Certificate(s) of acceptance of the Device(s) in full, within 3 (three) banking days from the date of establishment of the fact of damage and/or loss of the Device(s). recorded..
- b. If the camera is lost not as a result of the Subscriber's action and/or inaction, the Subscriber is not responsible for the loss if the latter provides the Operator with a decision from the RA law enforcement agencies in this case.
- c. In the case of the absence of a decision from the RA law enforcement agencies to exclude the Subscriber's guilt in theft, the Subscriber is obliged to pay a fine established by the Operator in the manner provided for in subsection 7.1 of these conditions.
- d. If the Subscriber changes the address, the Operator undertakes to dismantle the camera/cameras from the current address and install the camera/cameras at the new address in accordance with the current conditions.
