

TERMS OF THE "HAPPY SATURDAY SUNDAY" OFFER

1. Within the scope of the "Happy Saturday and Sunday" offer, for all subscribers of the "Trio", "Duo" and "Smart TV" service packages, who will pay for the Services provided during the reporting month within the period specified by the Operator and will not have any Service due to overdue debt during the current month. suspension of provision, then during the period from the day of suspension of services set for the current month due to overdue debt to the day of suspension of services set for the next month due to overdue debt (hereafter referred to as Month), on Saturdays and Sundays, "Duo", "Smart Television" packages will include "All movies in the "Film Library" section. This condition does not apply if any of the "5 views", "10 views", "20 views" or "100 views" packages are active with the Subscriber. If the subscriber has any of the "5 views", "10 views", "20 views" or "100 views" packages active, the movies watched on the specified days will reduce the number of remaining views of the movies included in the package.

The condition specified in this clause does not apply to series and series packages, and the conditions specified for series and series packages apply on the days specified in this clause. 2. Within the framework of the "Happy Saturday and Sunday" offer, to all subscribers of the "Mono" tariff package who will pay for the Services provided during the reporting month within the period specified by the Operator and will not have suspension of Services due to overdue debt during the current month, then for the current month due to overdue debt 20 Mb/s "Internet" speed will be provided on Saturdays and Sundays during the period from the day of suspension of the specified services to the day of suspension of the services specified for the next month due to overdue debt (hereinafter referred to as "Month").

3. The Subscriber who has already been provided with the conditions specified in points 1 and 2 of these terms and conditions on Saturdays and Sundays and during any of the following months has a suspension of Services due to an overdue debt, then the condition specified in point 1 of these terms and conditions 1 Closed on Saturdays and Sundays for a month. In case of non-termination of the Services due to overdue debt in the following months, the Subscriber will again use the "Happy Saturday and Sunday" defined in these terms.

from the special offer for 1 Month. Under these conditions, the "Happy Saturday and Sunday" offer continues to operate in the following months as well, depending on whether or not the Subscriber had a suspension of Services due to an overdue debt.

- 4. In case of temporary suspension of the provision of Services within the framework of the "Trio", "Duo" and "Smart TV" service packages and the "Mono" tariff package according to the subscriber's application, the period of application of the terms of the "Happy Saturday and Sunday" offer shall not be extended.
- 5. During the provision of the "Happy Saturday Sunday" offer, if the Subscriber switches to another Service/service package specified in these conditions, he continues to receive the conditions of the "Happy Saturday Sunday" special offer specified in the terms of the new Service/service package.
- 6. If the Subscriber activates the "Yearly Payment" service before the suspension of services due to overdue debt, and as a result, suspension of Services due to overdue debt does not occur, then during the given month, he also benefits from the terms of the "Happy Saturday and Sunday" special offer.
